Subject: National Council for Clinical Establishment - Inclusion of Representative of Indian Dental Association

The Indian Dental Association (IDA), the custodian of oral health in the country, is the largest recognized body of dental professionals in India. IDA has also been complementing and supplementing the government efforts to promote, encourage and achieve national goals to improve the overall health index in the country and the Ministry of Health was very appreciative of its contribution to the shaping of national oral health policy in the country.

We take this opportunity to compliment and congratulate you on enacting the Clinical Establishment (Registration and Regulation) Act, 2010. The provisions of this Act will certainly go a long way in the efficient regulation of clinical establishments while providing standard medical facilities and services with a humane approach.

Section 3 of this Act postulates the establishment of the National Council for Clinical Establishment with members chosen from various fields of allopathic and Indian system of medicine. Section 5 of the Act lays down the function of the National Council which has an important role to play with respect to the implementation and enforcement of the Act.

Amongst the Organizations/Associations which have been listed as members in the National Council for Clinical Establishment are representatives of the Indian Medical Association and the Indian System of Medicine Association. The Indian Dental Association, which is the largest body of dental professionals in the country, is not mentioned amongst the members of the National Council.

You will certainly agree that for the effective enforcement of the provisions of this Act in the field of dental science and for the balanced development of dental industry in the context of globalisation, inclusion of IDA in the National Council is absolutely necessary. Its non-inclusion will be prejudicial to the entire dental fraternity and will cause an enforcement vacuum which could prove detrimental to the objective of the Act inasmuch as representation of a large medical body will remain unheard, thus defeating the very purpose of the Act itself.

In view of what has been stated above, your kind intervention for the inclusion of IDA as an organization representing the dental fraternity is earnestly solicited on the likes of IMA and the Indian System of Medicine Association.

You are also further requested to kindly bring the necessary change by way of an amendment to Section 3 of the Clinical Establishment (Registration and Regulation) Act 2010 to give effective representation to IDA in the National Council for Clinical Establishment.
