*I would also humbly submit that a*mongst the various branches of medicine which have been recognized and listed as members in the National Council for Clinical Establishment are Allopathy, Ayurveda, Homeopathy and Unani. However, the discipline of oral health is not recognized. Oral diseases are on rise and it is high time for considering,

establishment of an oral health wing at the Ministry of Health & Family Welfare, GOI, to take care of oral diseases like oral cancer, gum diseases,

dental caries, etc. and a Chief Dental Officer appointed at the Department of Health and Family Welfare.

Oral Health Adviser to Health Ministry

It may not be out of place to mention here that, in view of the growing incidence of oral diseases and their links with systemic diseases, there is the need for a permanent Adviser on Oral Health matters to the Ministry of Health & Family Welfare as in the case of general Medicine. IDA could also act in an advisory capacity and assist the Ministry of Health and Family Welfare in implementing oral healthcare programmes in the country to improve the prevalent oral health scenario.

Representation of IDA in Dental Council of India

Dental Council of India regulates the dental education and the dental profession throughout the country. Various State Governments, Universities, Dental Colleges, Central Government, etc., are represented in the Council. IDA, the recognized body of dental professionals, is conspicuous by its absence. It is submitted that representation of the Indian Dental Association in the Dental Council of India may kindly be considered.

Representation of IDA in Medical Device Regulatory Authority of India

The Medical Device Regulatory Authority of India ensures the safety of the public in the use of medical devices by maintaining control relating to the quality, safety, efficacy and availability of medical devices used.
