Health inequities

You are well aware, Sir, that there are inequities in health outcomes on the back of regional disparities in health coupled with lack of awareness of oral hygiene. Oral health inequity and inequitable access to oral health services contribute to overall health inequity of the population. And it further worsens the socio-economic inequity.

Need for joint action

It is true that the task of provision of healthcare for all cannot be undertaken by the government alone. Other agencies in the healthcare field must also share the responsibility. We need to bring the various agencies involved in the provision of healthcare on a single platform to ensure effective implementation and efficient monitoring. All the stakeholders, viz., the Ministry of Health and Family Welfare, the concerned health ministries of the state governments, government hospitals and health institutions in the private sector and non-government organizations with their enviable outreach, have to embark on a common strategy of prevention and treatment of diseases. The "Swatch Bharat Abhiyan" initiative will add supplementary benefits in the form of improved national health by enhancing personal and environmental hygiene that leads to building a strong and healthy nation.

Strategy of prevention

IDA has been following a strategy of prevention of oral diseases. **Oral diseases are absolutely preventable**. This is done by organizing dental check up and awareness camps and implementing programmes related to oral cancer prevention and tobacco cessation. Such camps help educate people about the importance of oral hygiene and the measures employed for disease prevention. The aim is to reduce the incidence of oral diseases, particularly oral cancer. Campaigns against tobacco use have had favourable impact on its cessation.

Need of the hour

To improve health, what's needed is the availability of a system that provides authentic data of healthcare professionals at a point of time, state-wise, district-wise, gender-wise, speciality-wise. The Indian Dental Association (IDA) has developed a software that provides authentic data of its dental resources personnel. We have also developed a database for oral disease prevalence in the country.

The web-based software developed by IDA offers a digital system that provides authentic information of dental professionals in the country at a point of time state-wise, district-wise, gender-wise, speciality-wise. It can be accessed by all the stakeholders concerned, viz., the Ministry of Health and Family Welfare, Government of India, State Governments, Dental Council of India, and the State Dental Councils. The system has been implemented by a few State Dental Councils. It has facilitated effective utilisation and efficient deployment of dental personnel resources in the country and avoid areas of saturation or otherwise to improve dentist-population ratio. The system developed also enables concurrent monitoring by the Health Ministry for purposes of formulation of, or changes in, oral health policy.

The challenge

The challenge is to ensure delivery of quality oral healthcare services in an efficient and affordable manner. This called for a strategy to train the dental workforce with appropriate skills and cultural competence to adequately and efficiently provide dental care to a population growing in size and diversity. The software developed can be utilised for continuing education to keep the oral healthcare professionals abreast of advancements in dental technologies and therapeutic procedures. Clinical procedure standardisation and ensuring proper ethical standards, which IDA is working on, are intended to introduce uniform standards of care.

How can IDA assist the Government?

A similar software reflecting the database of healthcare professionals in respect of other fields of medicine can be developed with minor modifications since the basic structure is already available. It's only a matter of months. Such a reliable database in respect of healthcare professionals, their number and specialisations state-wise, district-wise and genderwise, in effect, will help effective deployment of healthcare professionals to combat the diseases in a given timeframe. It will also facilitate overall coordination and monitoring of the implementation of national health policy by the Health Ministry and other stakeholders. IDA, as a part of its social responsibility, is prepared to assist the government in this regard in its effort to improve the health of the people through a strategy of universal healthcare to usher in a new dawn in overall healthcare.

This, I am quite positive, would throw light on the usefulness of the software as an effective tool for monitoring health inequalities by the government enabling corrective action.
