Respected Sir,

With reference to the captioned subject, we wish to inform you that the Maharashtra State Dental Council (MSDC) was conducted last election since 2007. The consequent election was to be held in the year 2012. A list of consequences happened with regard to conduction of election is given as under:

- 1. 5th November, 2012 election under the category 3 (a) was due
- 2. 27th December, 2012 Dr. M. G. Pawar was appointed as Returning Officer
- 3. 20th June, 2015 Dr. Jagdish Tupkari was appointed as Returning officer
- 4. 12th April, 2016 Dr. S. Barpande is appointed as Returning officer
- 5. 27th July, 2017 Financial request / plan was approved by the Government of Maharashtra

We would like to put it to your notice that during the period we have regularly followed up with the Government on this issue and we are thankful to the Government of Maharashtra for taking timely actions.

However, for whatsoever reason, the election is yet to be conducted. In such a scenario, for almost last five years, the Government of Maharashtra is not able to represent itself at the National Dental Council through its elected representative.

Therefore, we request you to kindly take cognizance of this issue and initiate necessary actions for holding election immediately by the concerned authority.
