Sir,

Dental Science is a part of Medical Science and though it is important from the point of rehabilitation of an important part of the human body i.e. Teeth, the general impression created is that dental treatment is cosmetic in nature. However, in reality it is not so.

Dental Science is developing and its treatment is equipment-oriented. Unfortunately, many of the Dental equipments, Instruments and Materials are imported. There are more than 150 Dental Colleges in India and as many as 10,000 students graduating every year. There is very little scope of employment for these Dental Surgeons. Under the circumstances, they have no option but to open a Clinic under self employment. Unfortunately, many Dental Equipments and Materials are imported and due to various type of Taxes like basic Customs Duty - 15%, CVD -8% + Cess, the value of equipment will suffer duty/tax to the tune of 25%. In addition to this, it will suffer sales tax of 8% to 15% (different rates applicable by each State) making the tax component of 40% on the Equipment, Instrument and Materials used by the self-employed Dental Surgeon's for imparting treatment.


Considering that a majority of the Dental Surgeons are self-employed, the Indian Dental Association on behalf of the Dental Surgeons, request you to sympathetically consider for the reduction of incidence of TAX as mentioned hereunder.
